Walter N. Thayer, Special Consultant to the President and a member of the President's Advisory Council on Executive Organization, today announced the appointment of Murray Comarow as Executive Director of the Council. Andrew M. Rouse, who has been serving as Executive Assistant to the Council has been appointed Deputy Director.

Comarow, 49, is vice president of Eooz, Allen and Hamilton and has had almost 30 years of Federal service. His last government post was that of Executive Director of the Federal Power Commission, where from 1966 to 1969 he had operating responsibility for the 1,100 man agency. For a year during this period, he was appointed by the President to serve as the Executive Director of the Commission on Postal Organization.

Comarow was with the Office of the Secretary of the Air Force for 8 years prior to joining the Federal Power Commission. He served as Assistant General Counsel from 1961 to 1966.

Rouse has been Director of the Resources and Flanning Staff of the Bureau of the Eudget. Previous to that, he served as a Senior Associate of Arthur D. Little, Inc. He holds a LLB from Columbia and a Masters in Business Administration from Harvard.

Comarow is married to the former Dena Blitz of Rock Island, Illinois and they have two children.
